

### The challenge Project team coordination

Unlike other web development agencies, Tinkerbox's strong product development focus means that the "company is a stickler for building clients" 'future-proof' software. With a diverse team made up of designers, developers, and strategists, it's vital that everyone is across workflows in order to ensure proper project management. Initially, the Tinkerbox co-founders were using personal Dropbox accounts as a file storage solution for the dayto-day running of operations. As the company grew quickly from a small team of co-founders in 2007 to a team of 25+ specialists today, it was obvious that a more permanent solution was necessary. As Kevin Tham, COO and Co-founder of Tinkerbox explains, "Before Dropbox Business, we had ongoing project management issues. Every team member had a personal Dropbox account so we didn't have visibility or control over all of our company files. The storage restrictions also quickly became problematic."

#### The solution Seamless coordination

As one of the early adopters of Dropbox Business, the Tinkerbox team were quick to embrace the collaboration solution.

As Tham explains, "We knew as soon as it came out that Dropbox Business was the solution that we needed. We can now work on end-to-end projects seamlessly and with a greater amount of visibility over workflows. I don't have to constantly worry about where a particular file is stored."

In addition, Tinkerbox needed to implement a range of access levels for each project team and staff member. "With Dropbox Business we can easily designate granular levels of access to team members. We store employment contracts, admin files, and other sensitive company information in Dropbox Business and we know that only the right people have access to these files."

The Tinkerbox team were also early adopters of Dropbox Paper, a flexible online workspace, which the team uses for keeping meetings on track. "We use Dropbox Paper for recording agenda items and minutes during our meetings. Additionally, it also allows us to easily assign tasks to relevant team members on the spot." says Tham.
